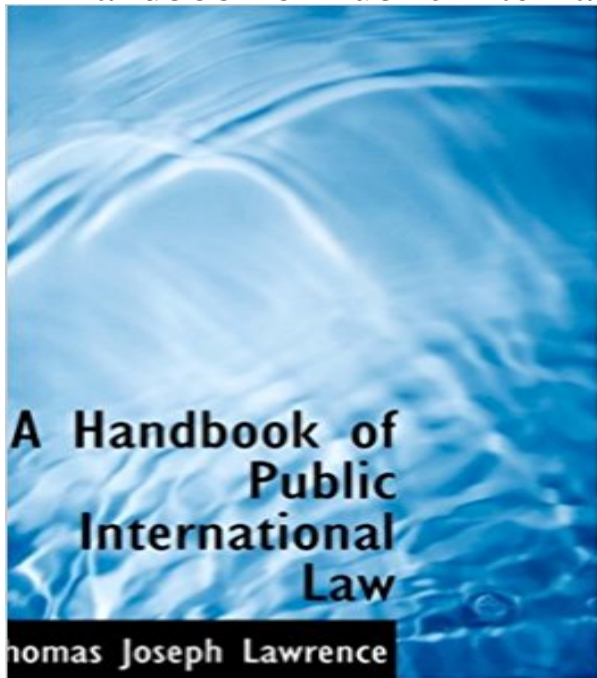


# A Handbook of Public International Law
