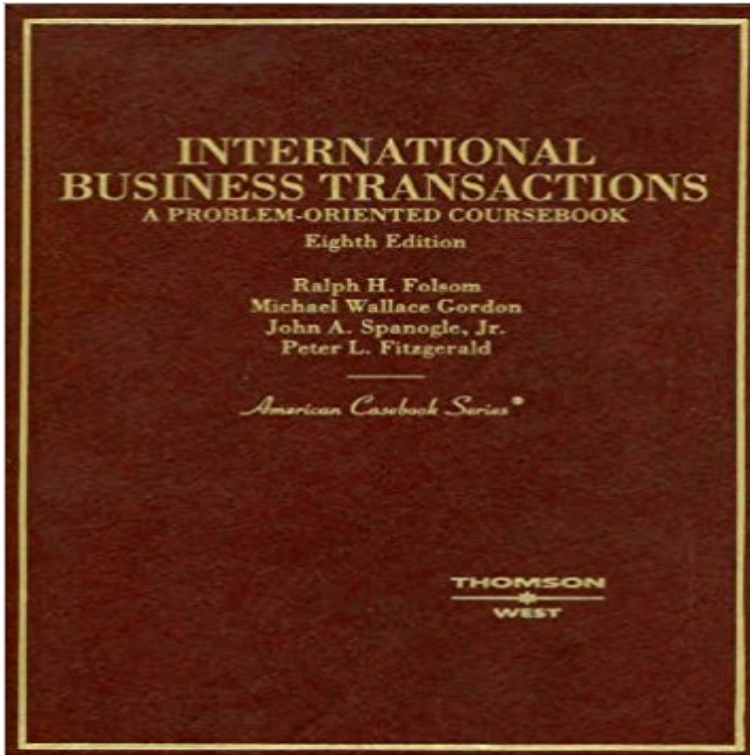


# International Business Transactions: A Problem-Oriented Coursebook, 8th Edition
