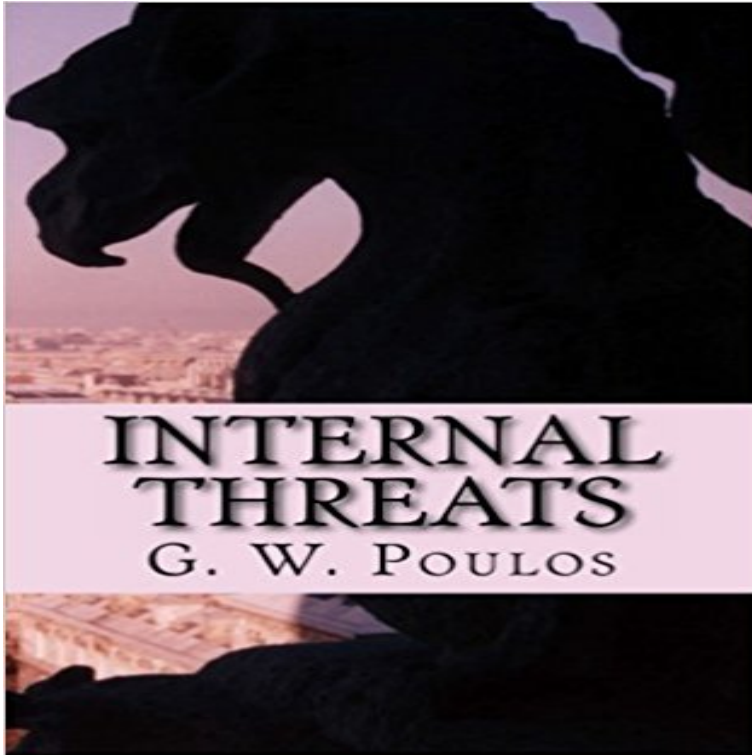


## Internal Threats
