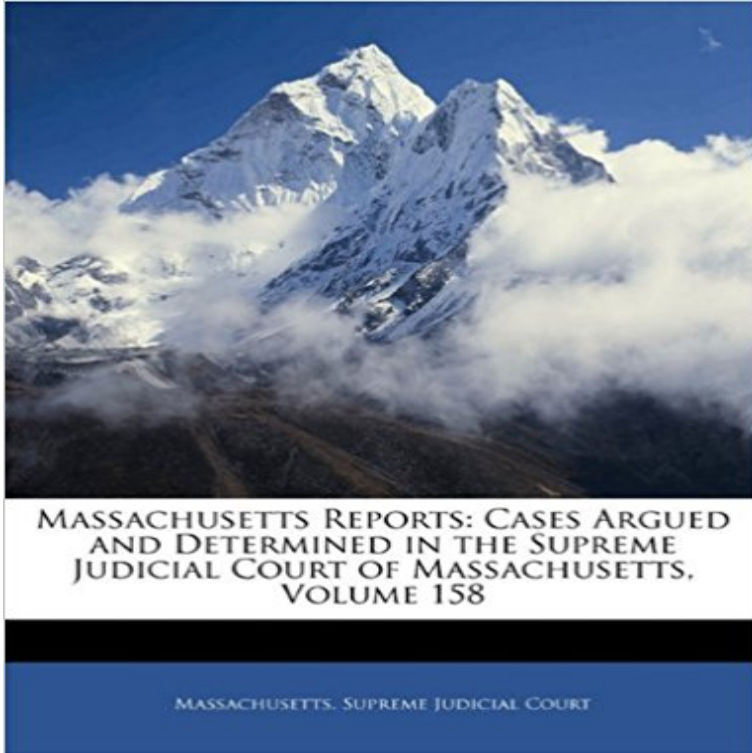


Massachusetts Reports: Cases Argued and Determined in the Supreme Judicial Court of Massachusetts, Volume 158
