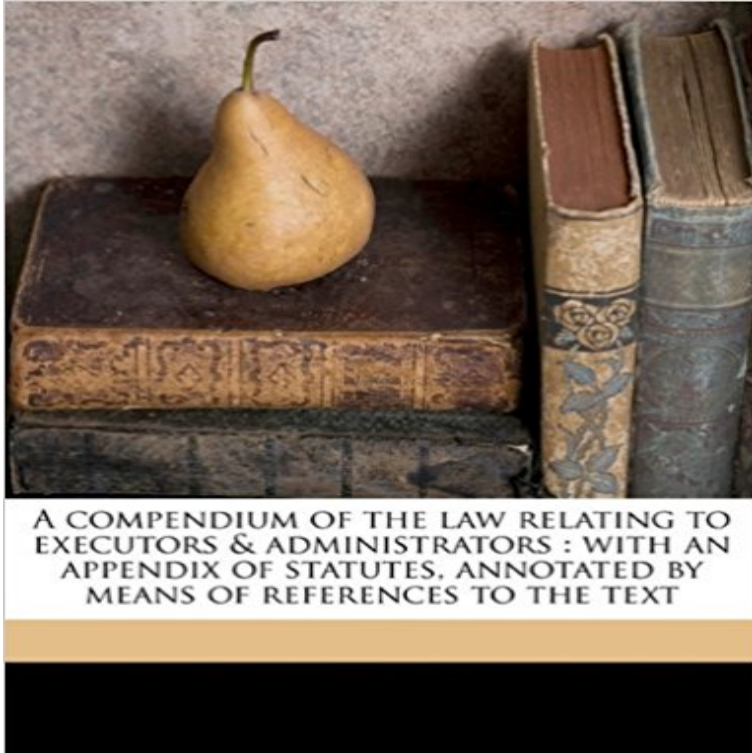


A compendium of the law relating to executors & administrators: with an appendix of statutes, annotated by means of references to the text
