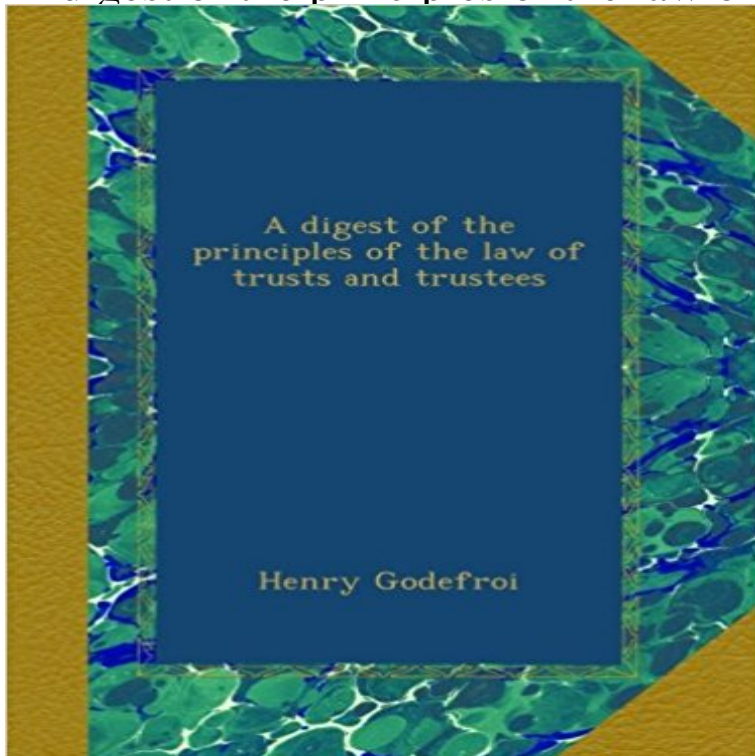


## A digest of the principles of the law of trusts and trustees
