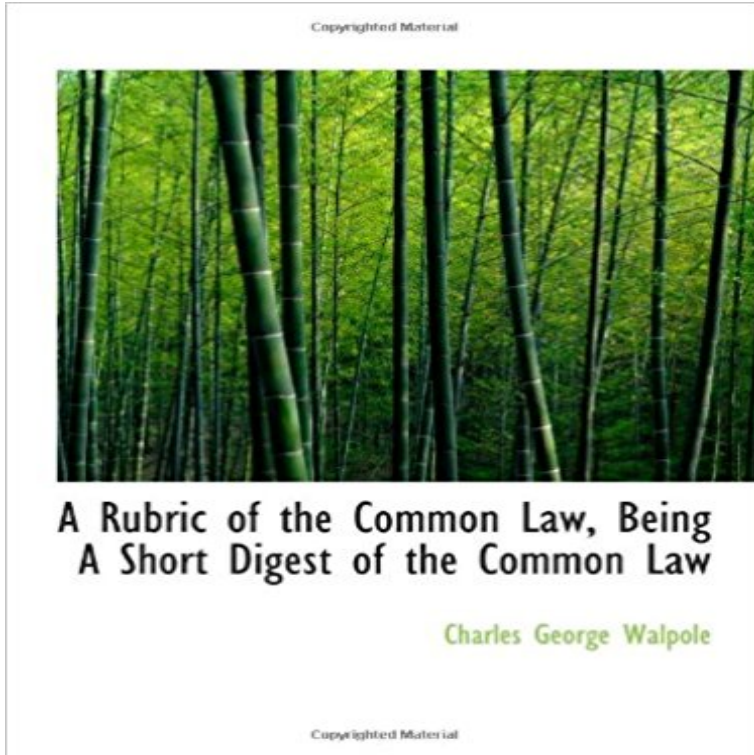


# A Rubric of the Common Law, Being A Short Digest of the Common Law
