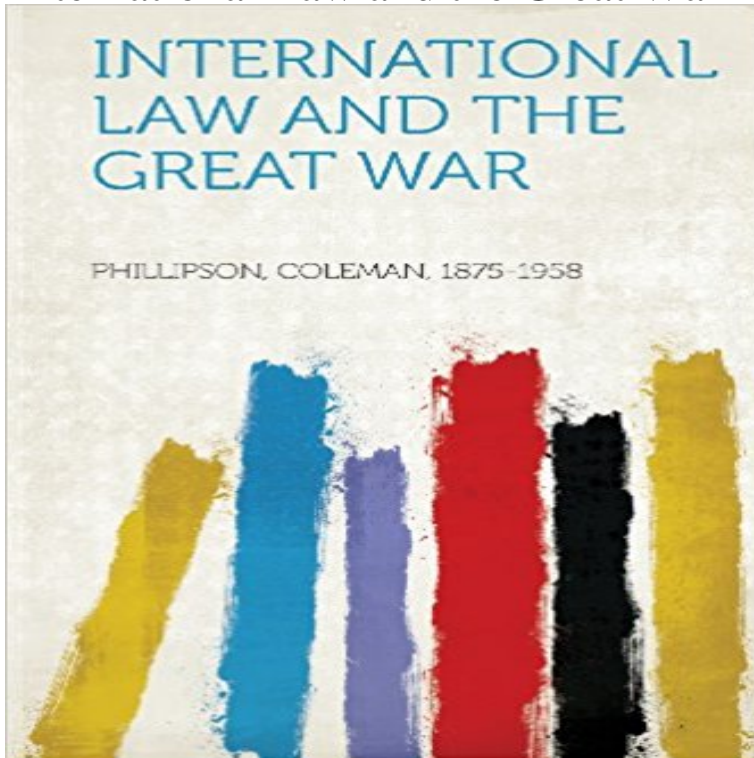


## International Law and the Great War
