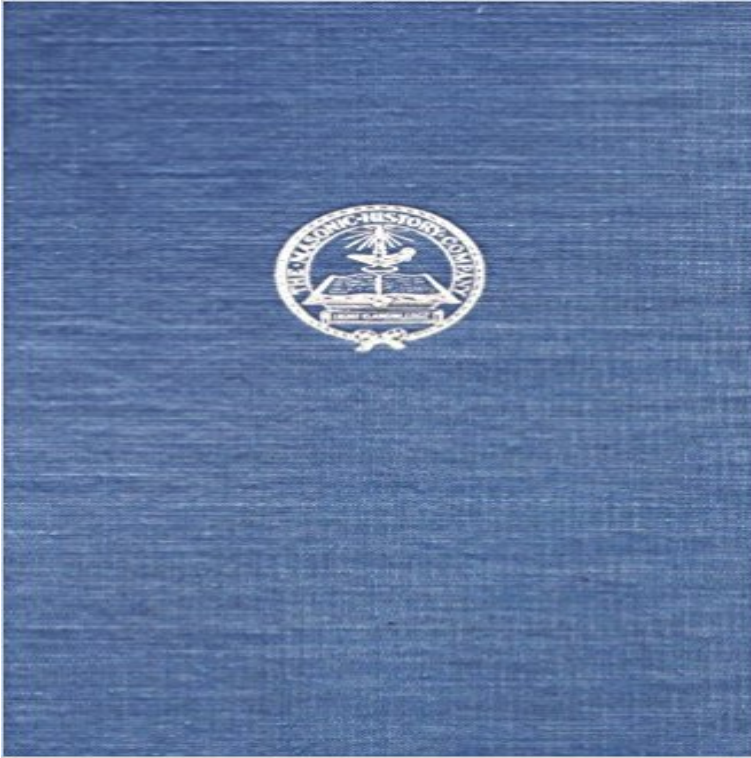


# Jurisprudence Of Freemasonry: The Written And Unwritten Laws Of Freemasonry

Since his death his pronouncements have been verified and approved by various Masonic scholars and jurists; the last revision having been made for us by the late Robert I. Clegg. He left the original Mackey text virtually intact making all changes and comments by means of copious footnotes at the bottom of the several pages. These notes are chiefly recent decisions of Grand Masters and enactments of Grand Lodges. They serve to clarify the book and bring it down to date and are a very important contribution and an invaluable addition to the book.
