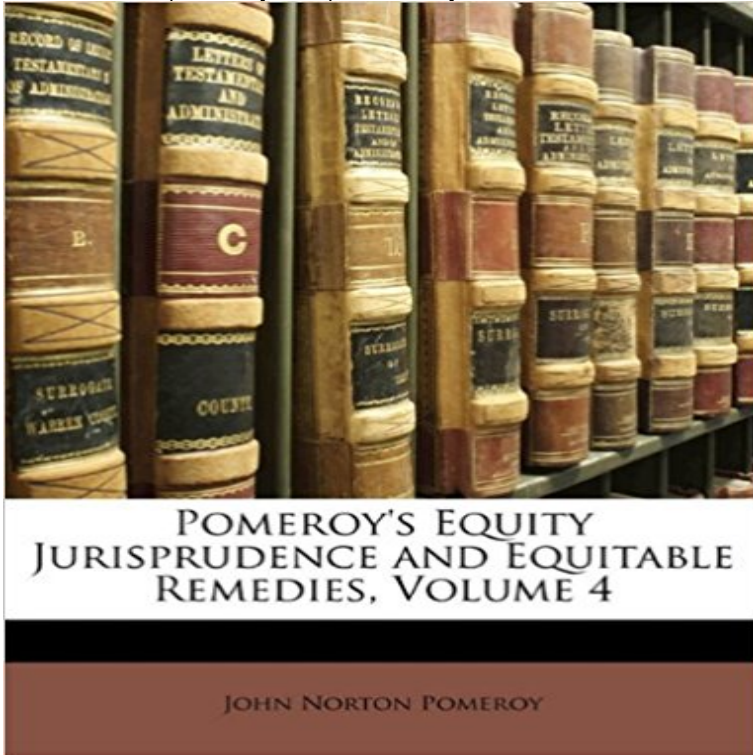


# Pomeroy's Equity Jurisprudence and Equitable Remedies, Volume 4
