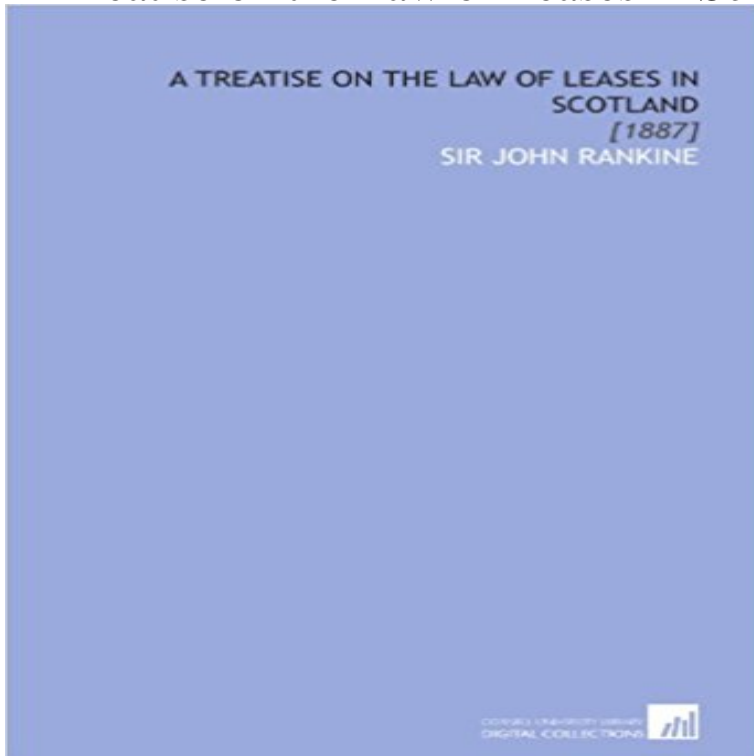


A Treatise on the Law of Leases in Scotland: [1887]
