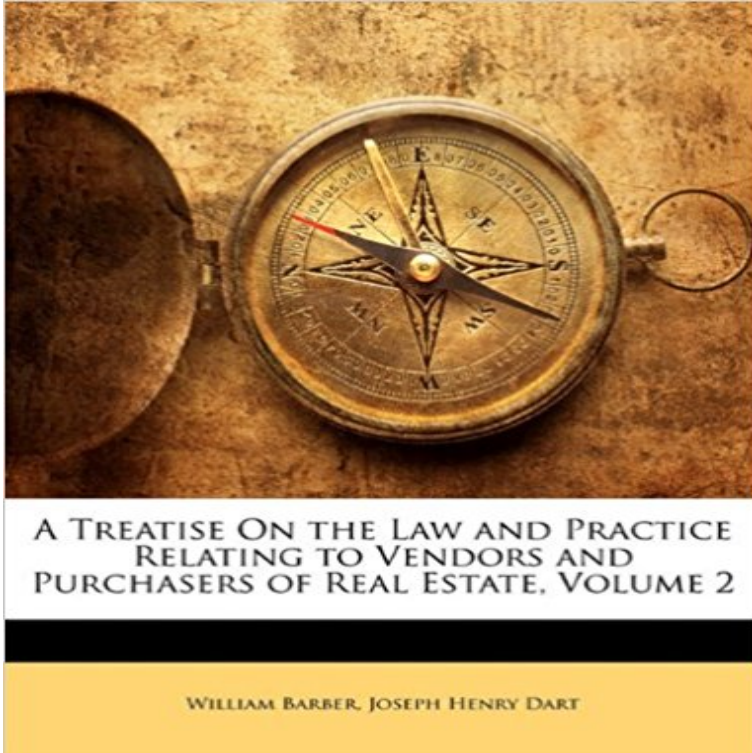


# A Treatise On the Law and Practice Relating to Vendors and Purchasers of Real Estate, Volume 2
