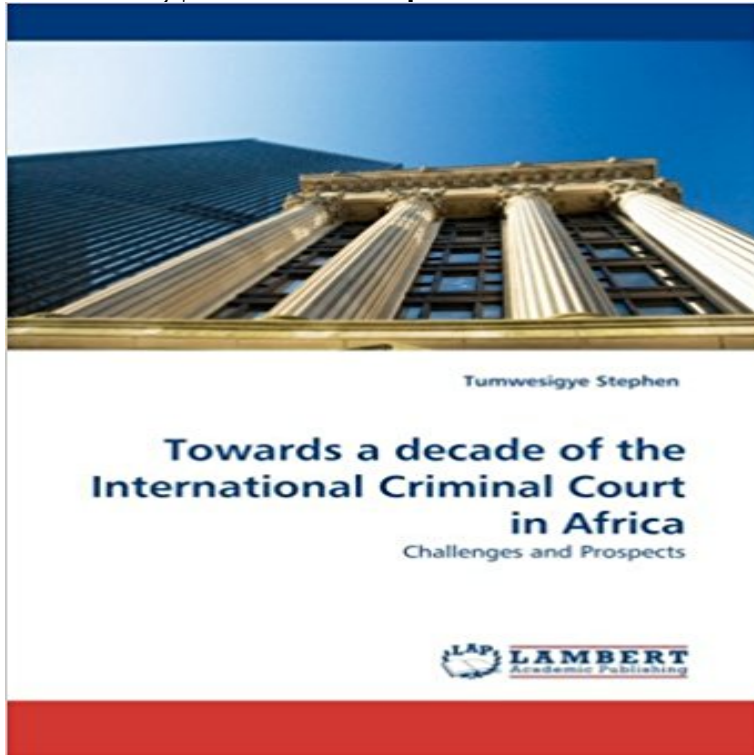


# Towards a decade of the International Criminal Court in Africa: Challenges and Prospects
