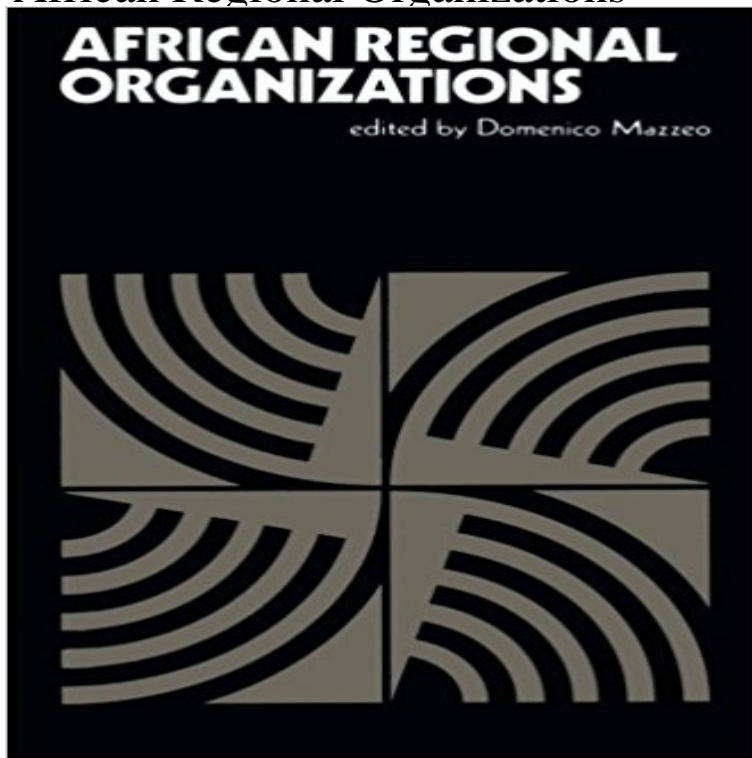


African Regional Organizations

It deals with African relations with the United Nations, as well as continental (OAU, ECA and ADB) and subcontinental (OCAM, UDEAC, ECOWAS, EAC and SADCC) organizations of a security, political, financial and common market type, and provides a comparative study of problems, trends and prospects. The major problems of international cooperation in Africa are analysed from a historical perspective and possible alternative roads to cooperation are suggested. Written to appeal to both scholars and policymakers, this book will be of value to anyone with an interest in African politics and the process of economic integration.
