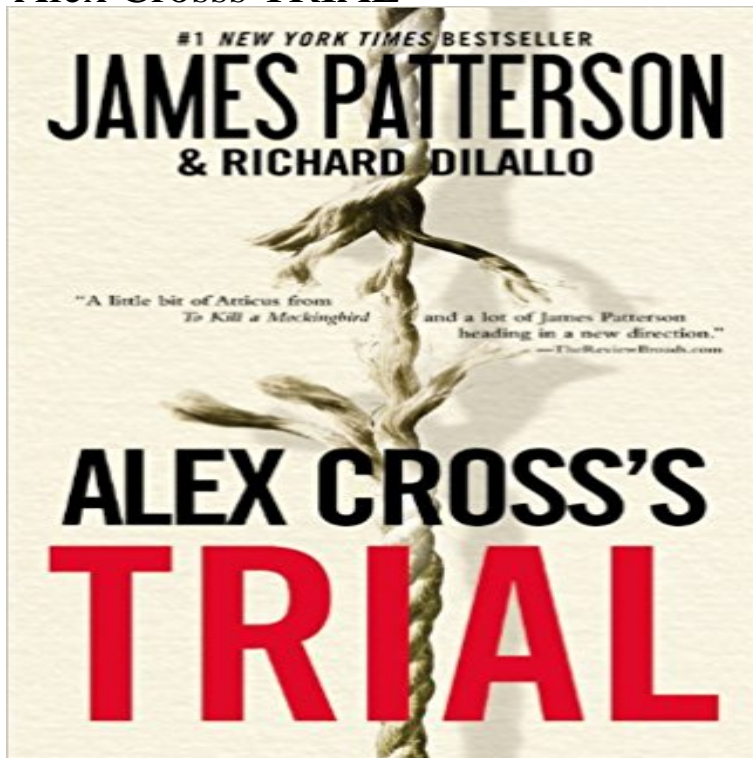


## Alex Cross TRIAL
