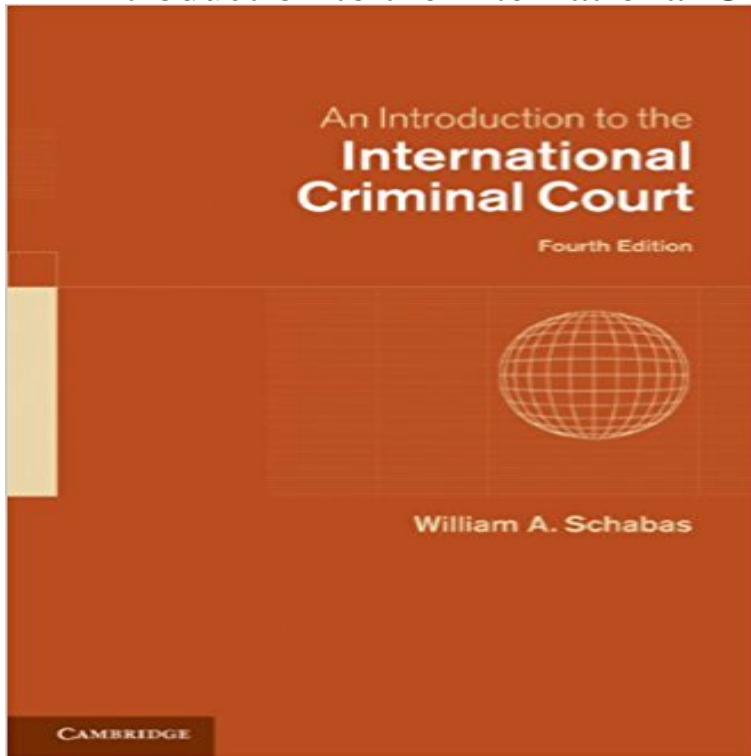


An Introduction to the International Criminal Court
