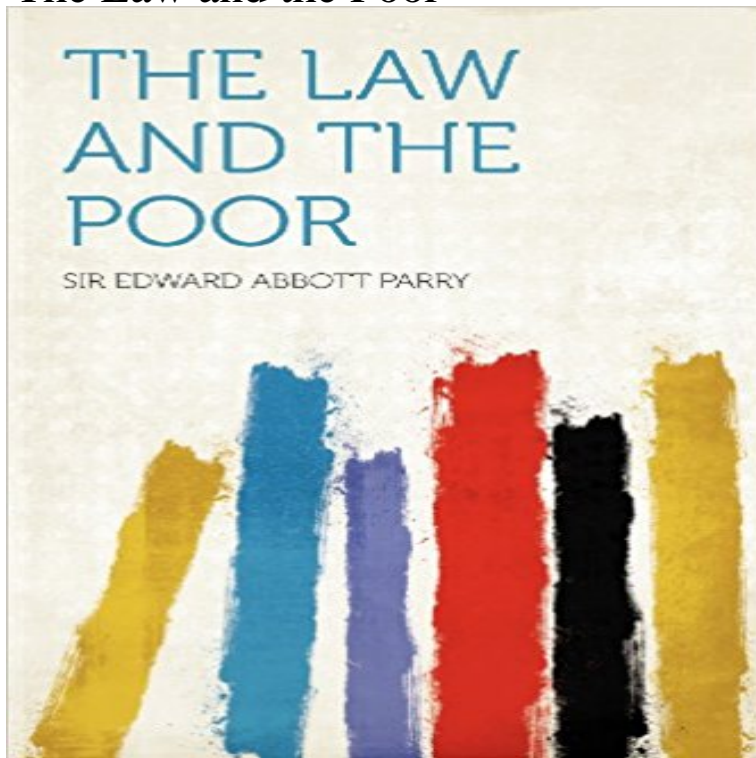


# The Law and the Poor
