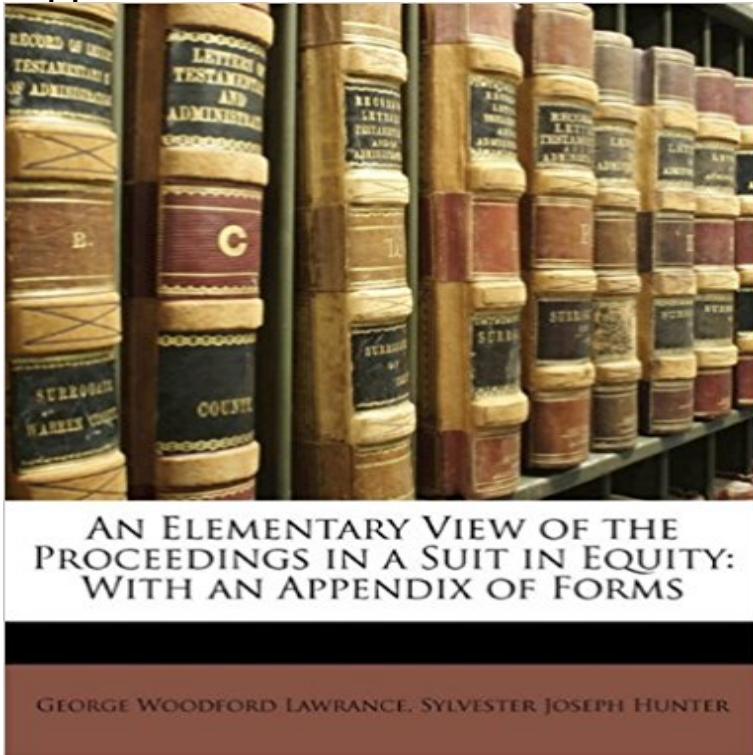


# An Elementary View of the Proceedings in a Suit in Equity: With an Appendix of Forms
