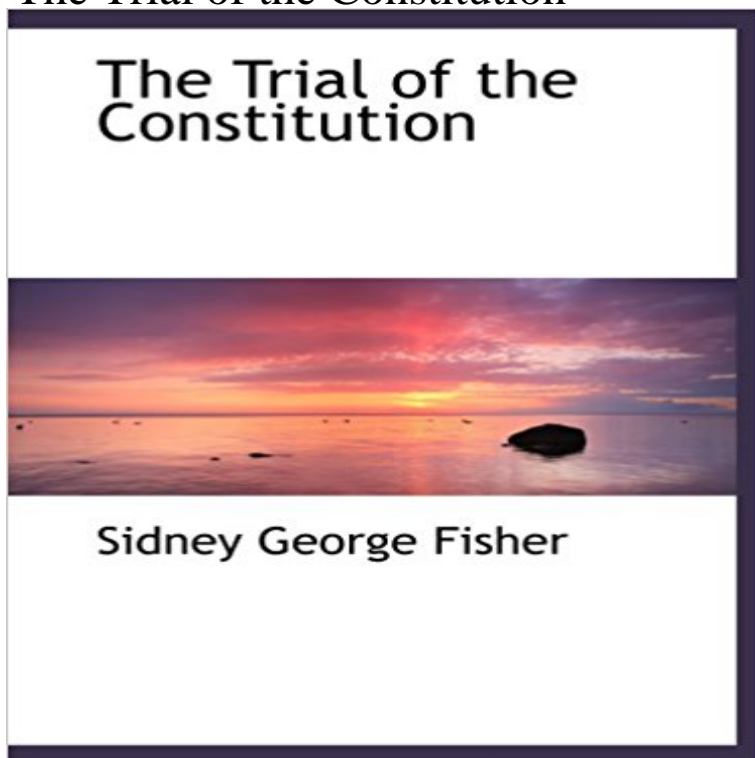


## The Trial of the Constitution
