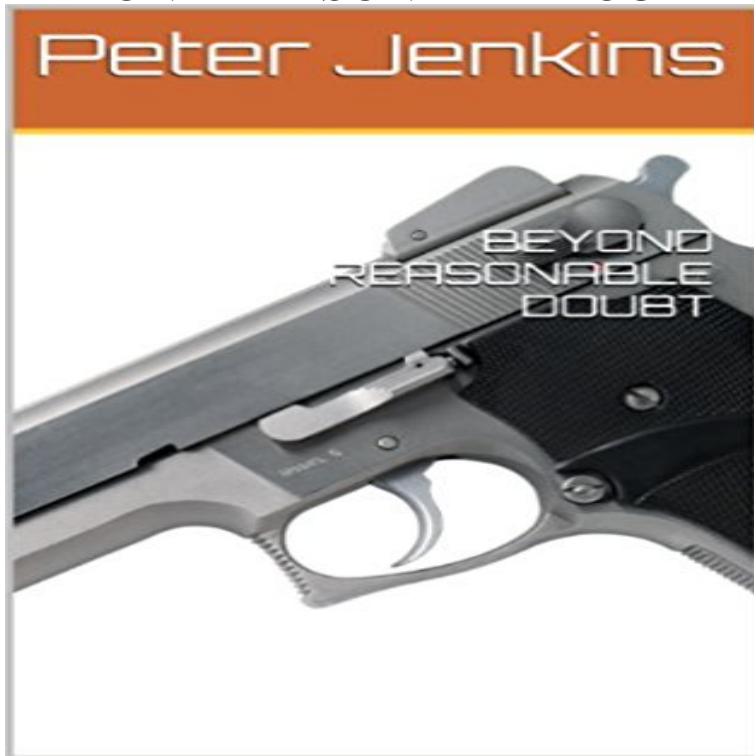


## BEYOND REASONABLE DOUBT
