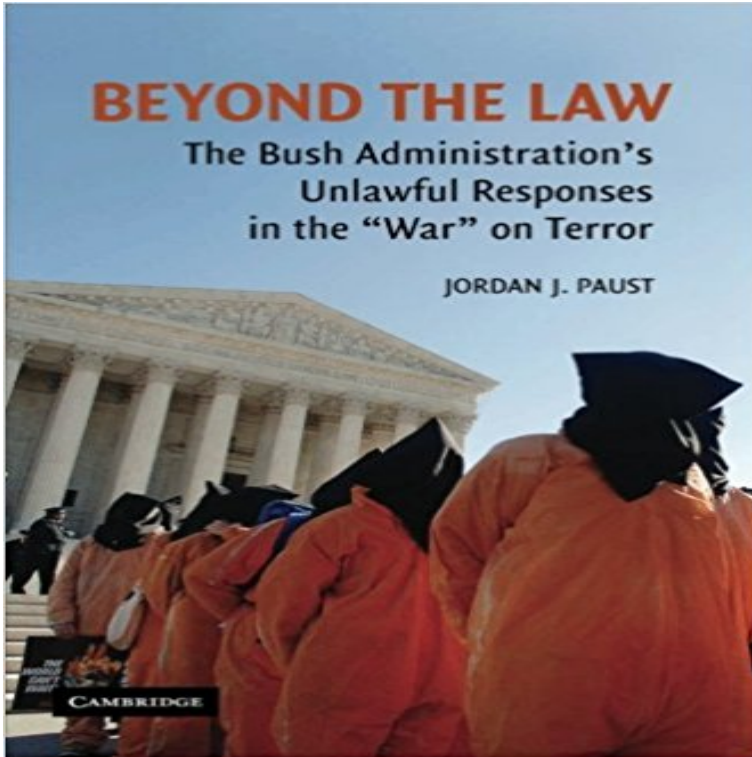


# Beyond the Law: The Bush Administrations Unlawful Responses in the War on Terror
