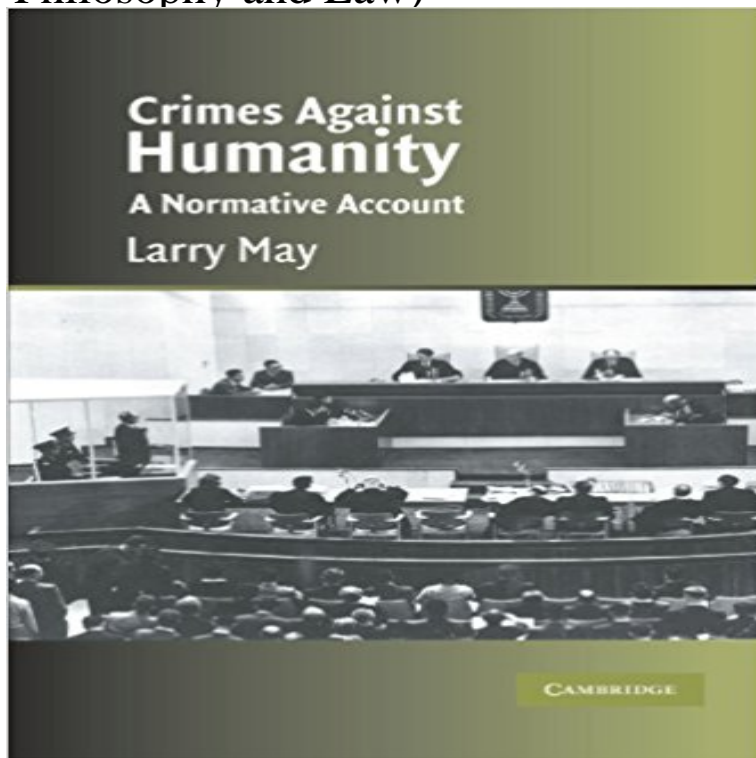


Crimes against Humanity: A Normative Account (Cambridge Studies in Philosophy and Law)
