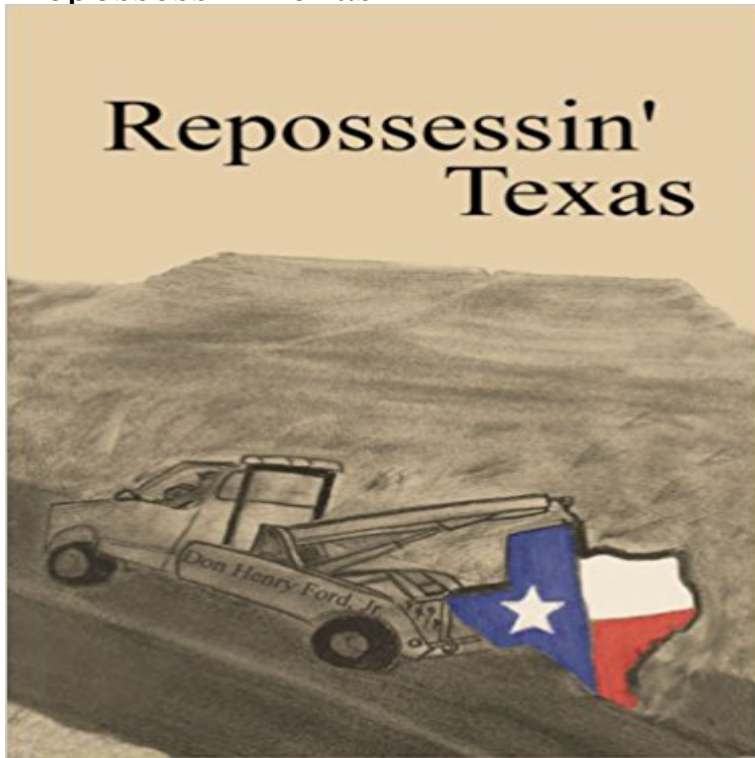


## Repossessin Texas
