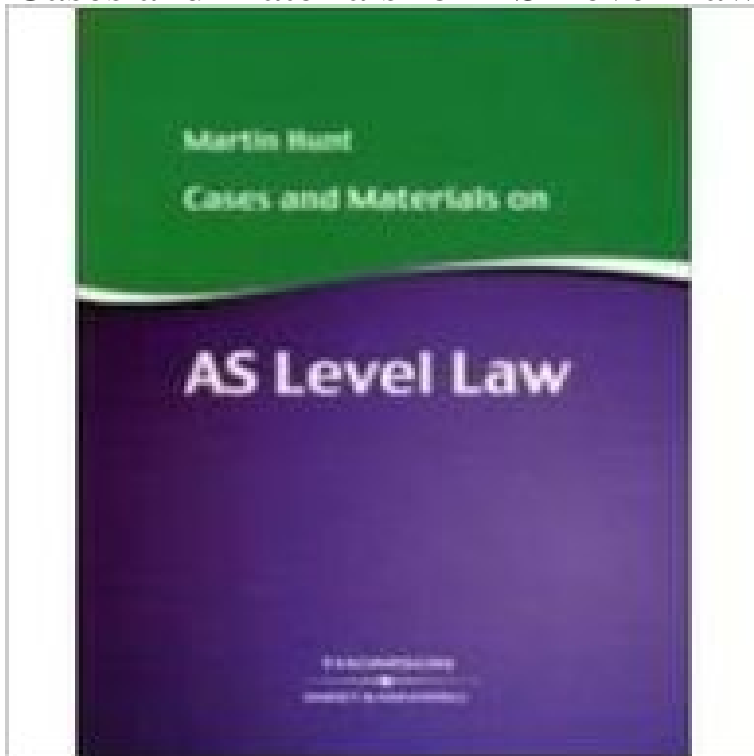


## Cases and Materials for AS Level Law
