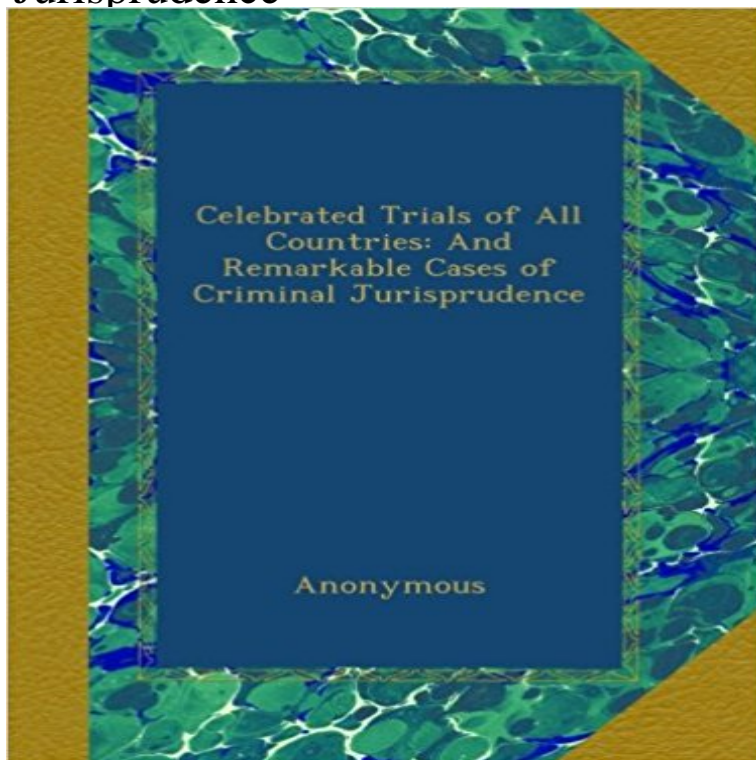


# Celebrated Trials of All Countries: And Remarkable Cases of Criminal Jurisprudence
