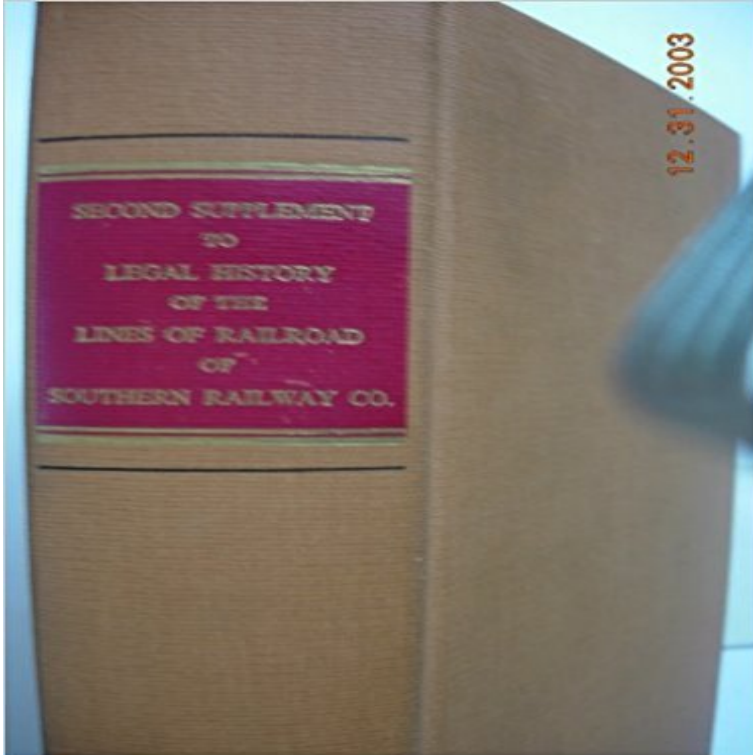


## Second Supplement to Legal History of the Lines of Railroad of Southern Railroad Company
