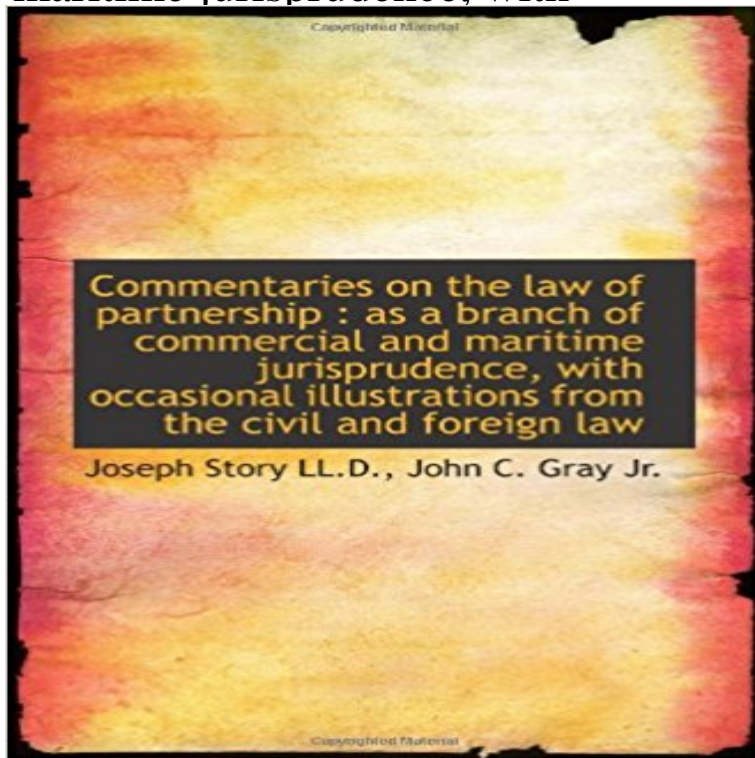


# Commentaries on the law of partnership : as a branch of commercial and maritime jurisprudence, with
