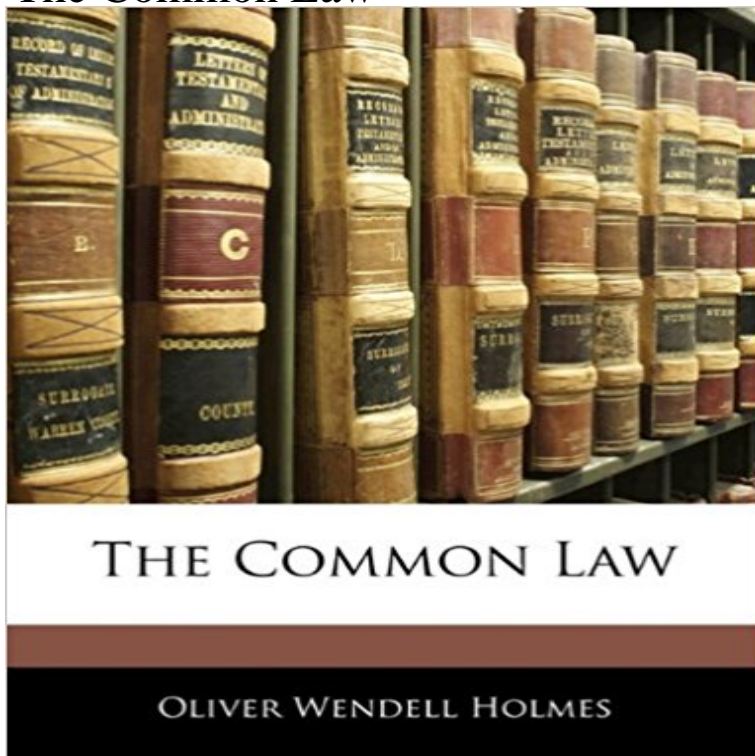


# The Common Law
