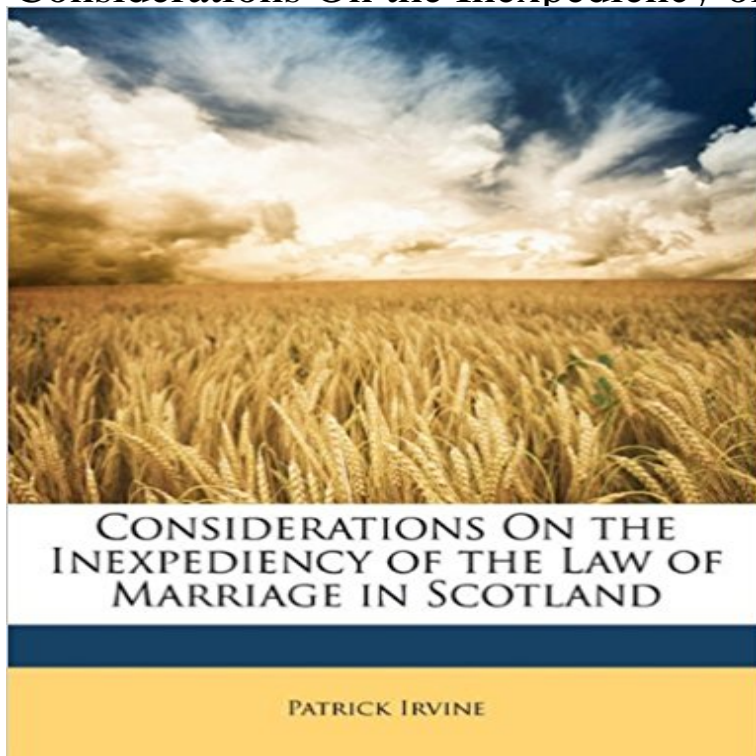


# Considerations On the Inexpediency of the Law of Marriage in Scotland
