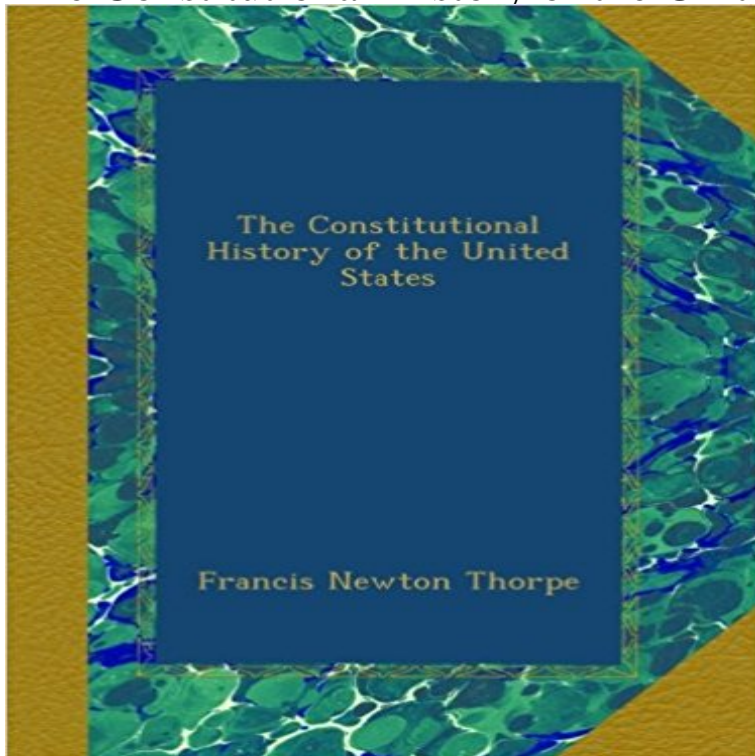


The Constitutional History of the United States
