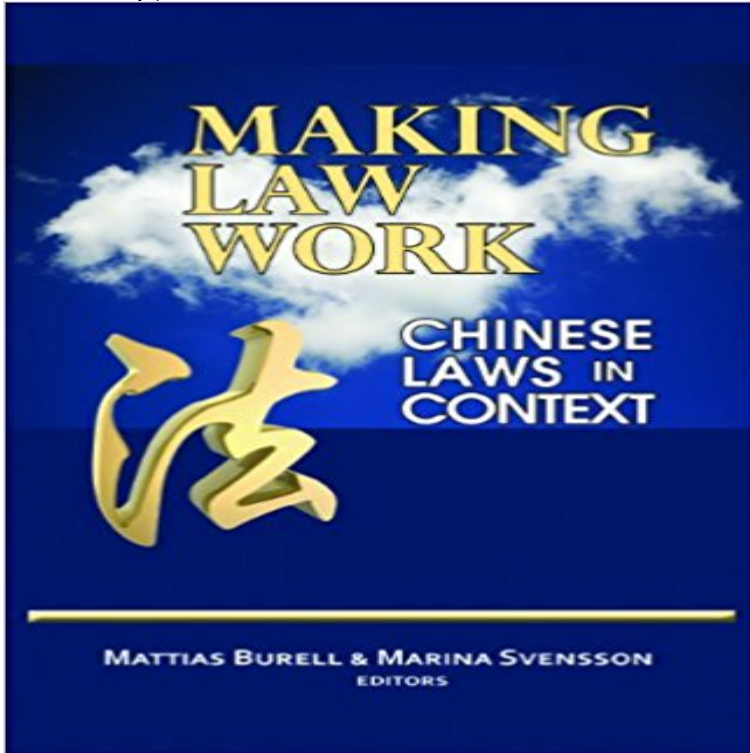


Making Law Work: Chinese Laws in Context (Cornell East Asia Series)

Successful implementation depends upon many different preconditions, which includes political will, legal knowledge and level of education among officials and other actors, effective enforcement mechanisms, popular trust, and favorable socioeconomic factors.
