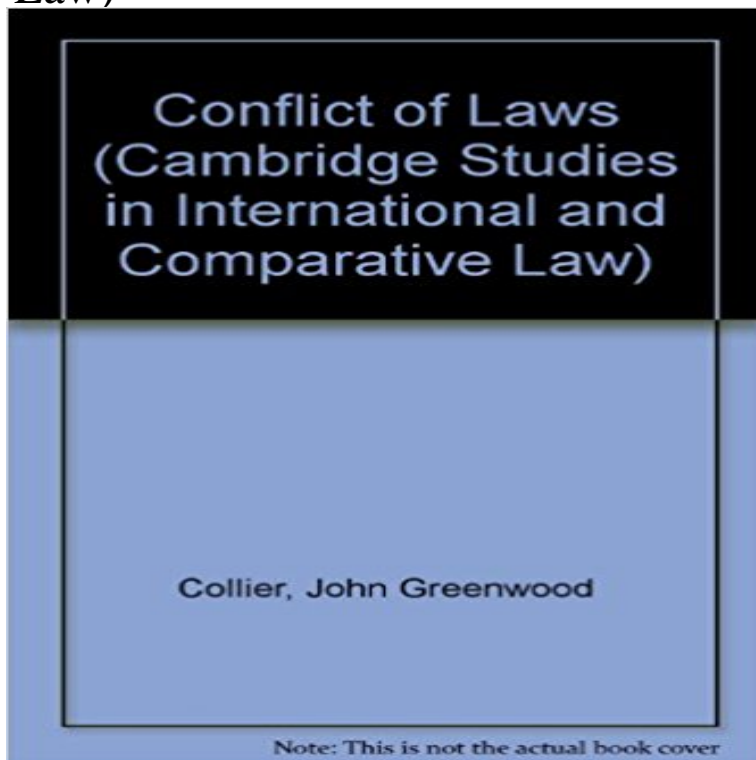


# Conflict of Laws (Cambridge Studies in International and Comparative Law)
