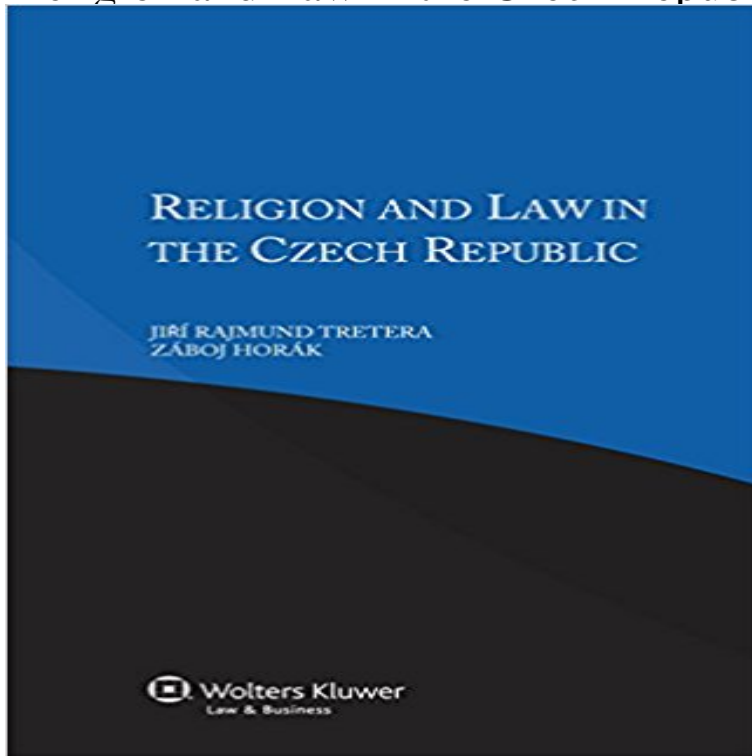


## Religion and Law in the Czech Republic
