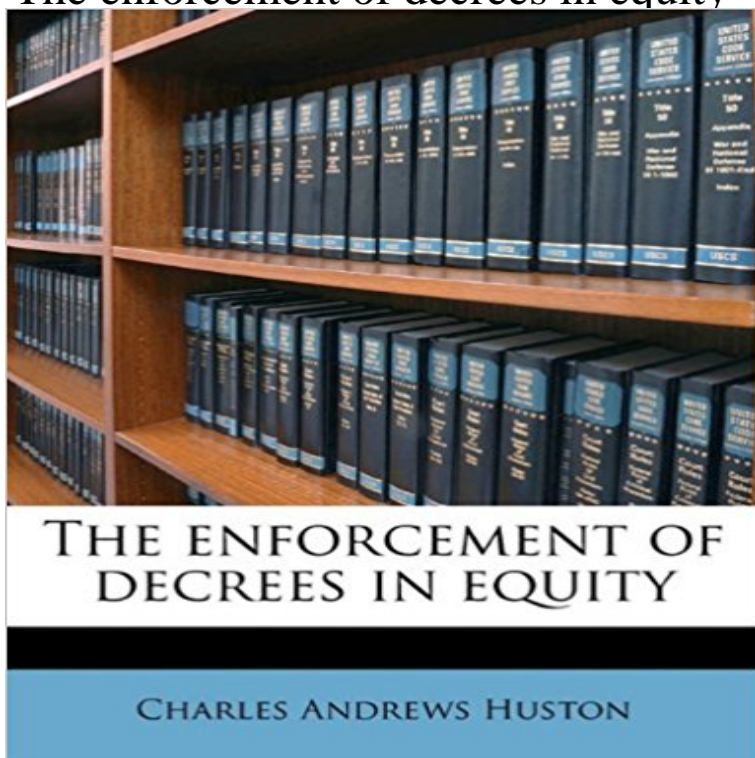


## The enforcement of decrees in equity
