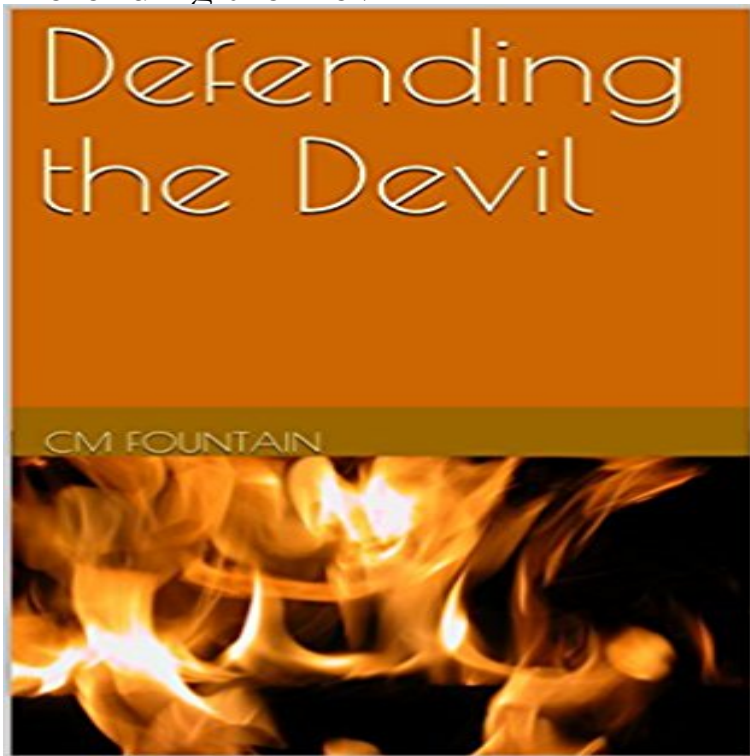


Defending the Devil
