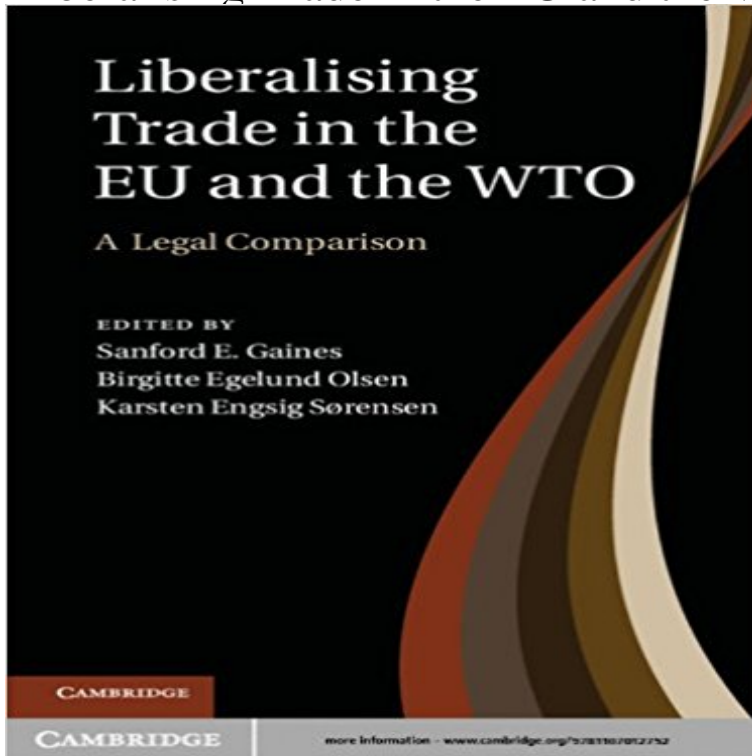


Liberalising Trade in the EU and the WTO
