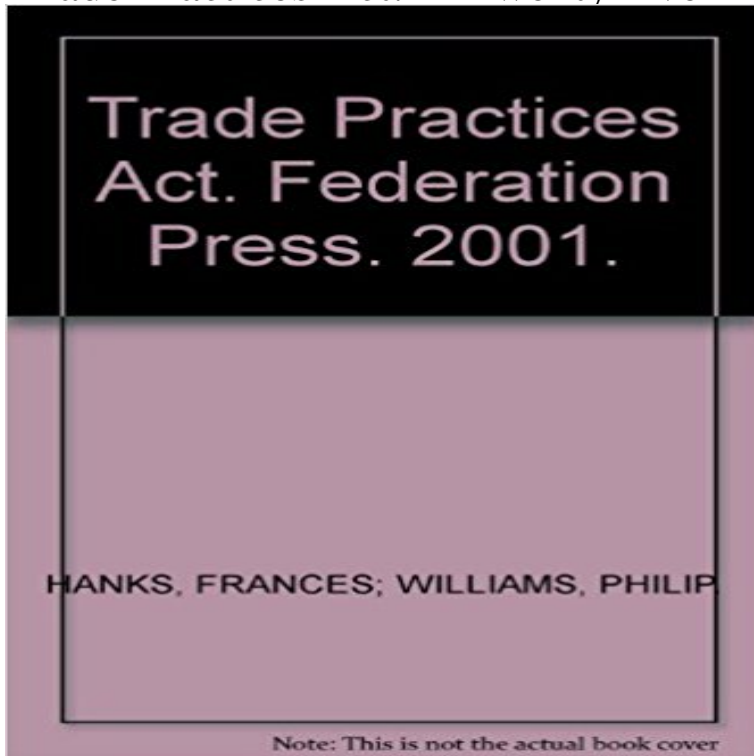


Trade Practices Act: A Twenty-five Year Stocktake
