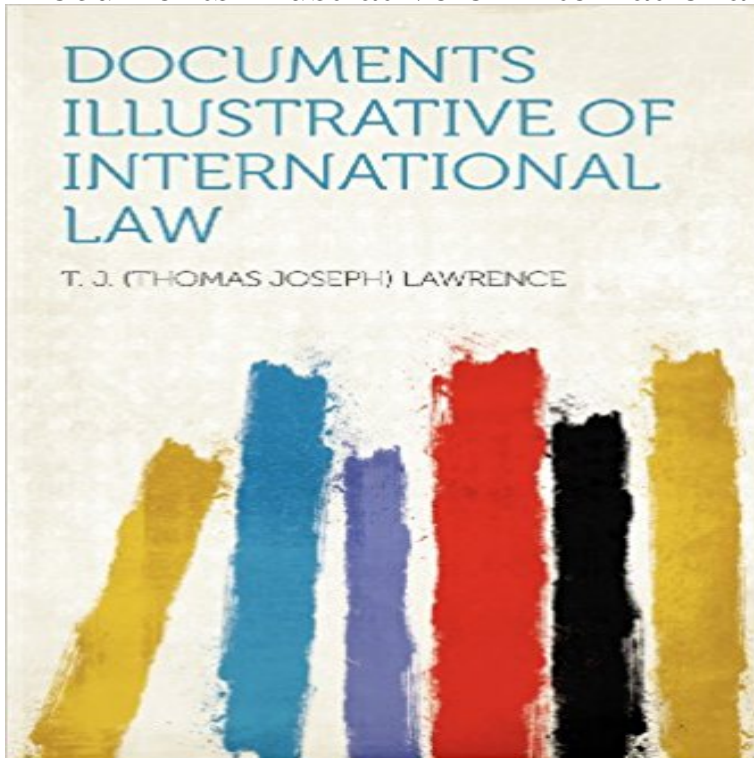


Documents Illustrative of International Law
