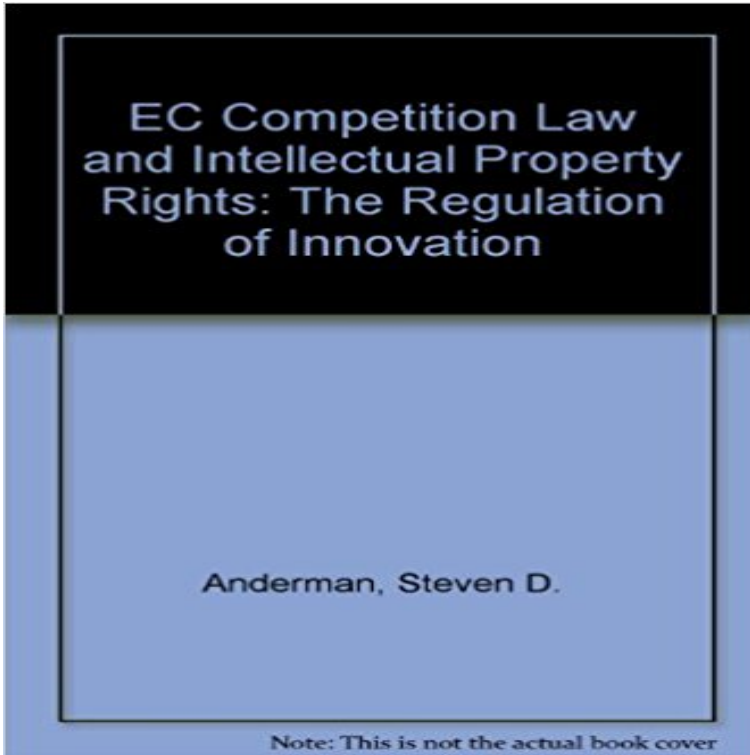


# EC Competition Law and Intellectual Property Rights: The Regulation of Innovation
