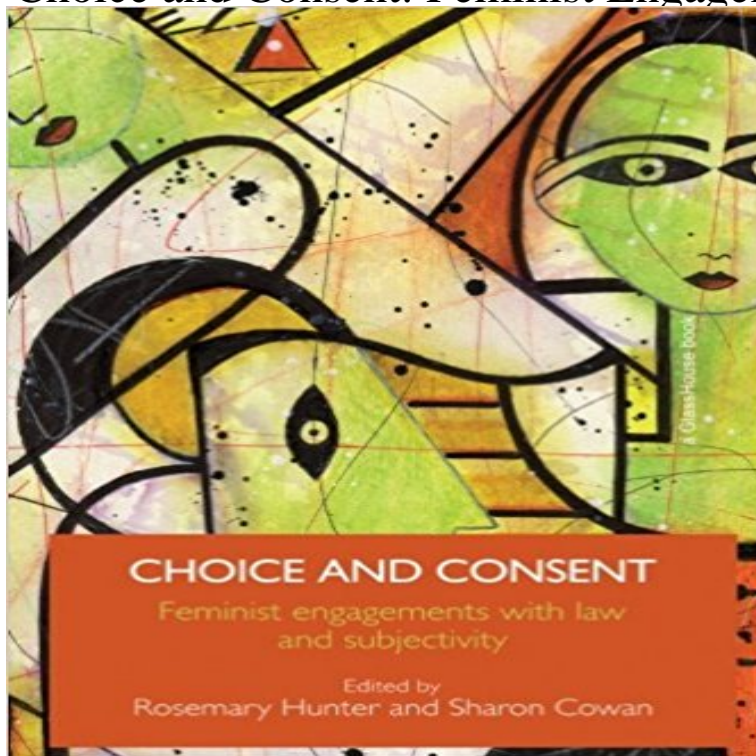


## Choice and Consent: Feminist Engagements with Law and Subjectivity
