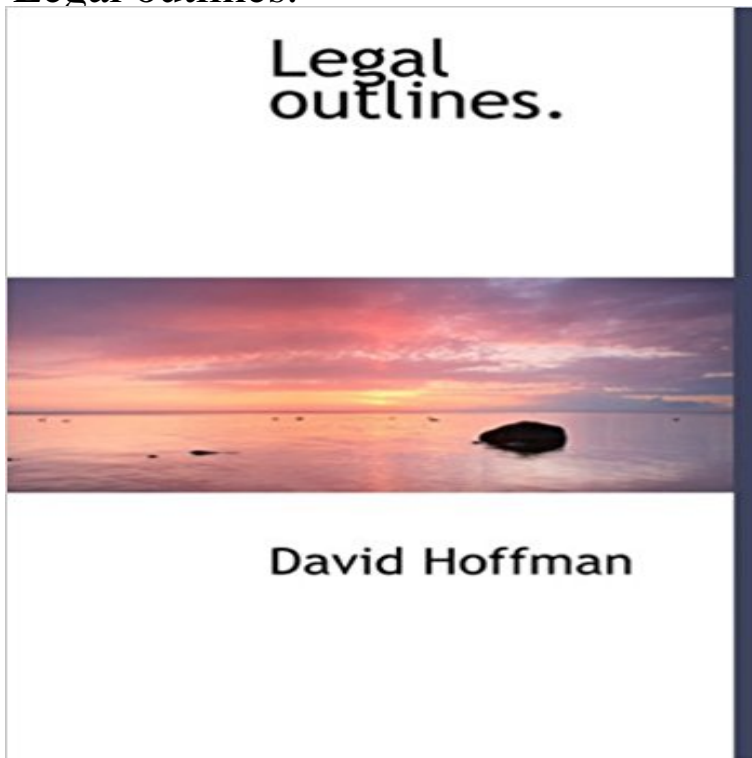


## Legal outlines.
