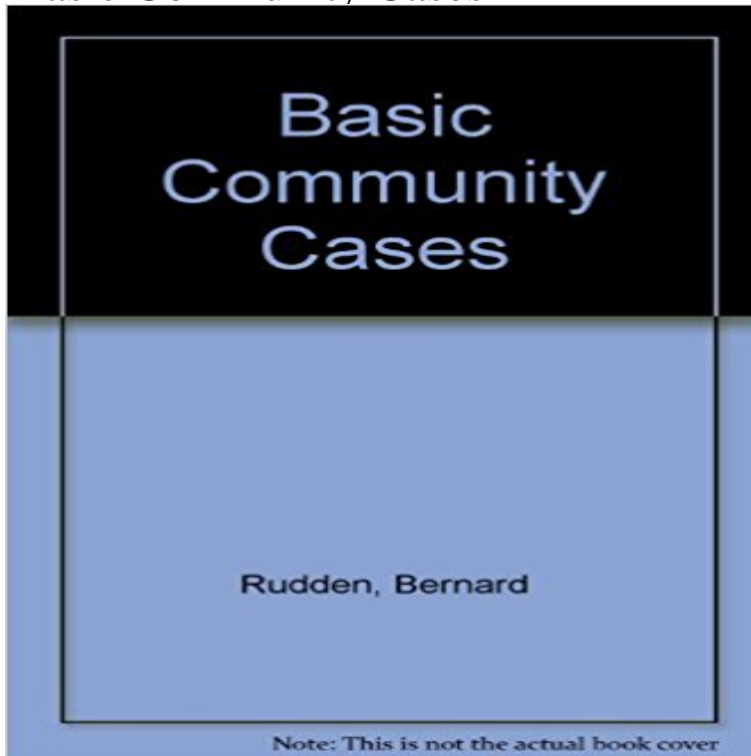


## Basic Community Cases
