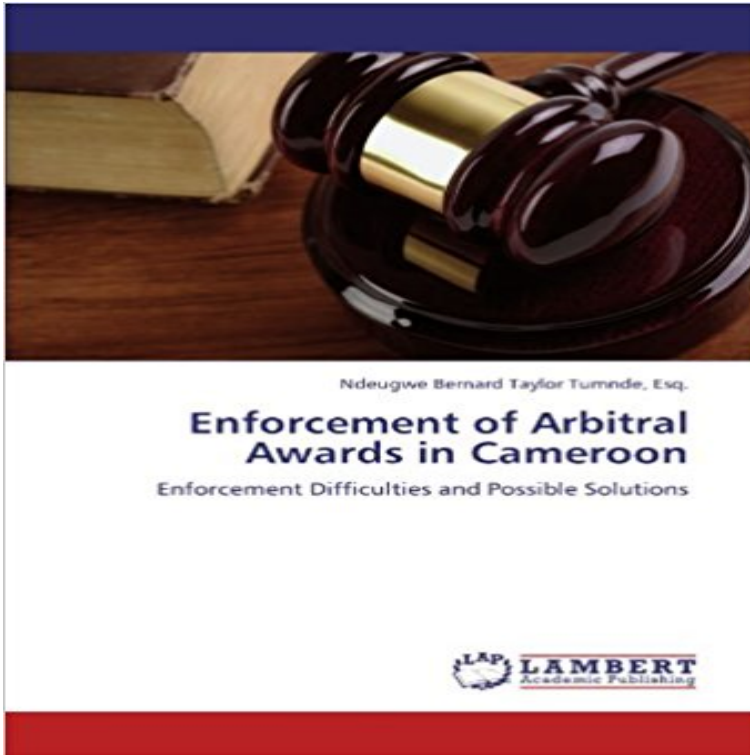


Enforcement of Arbitral Awards in Cameroon: Enforcement Difficulties and Possible Solutions
