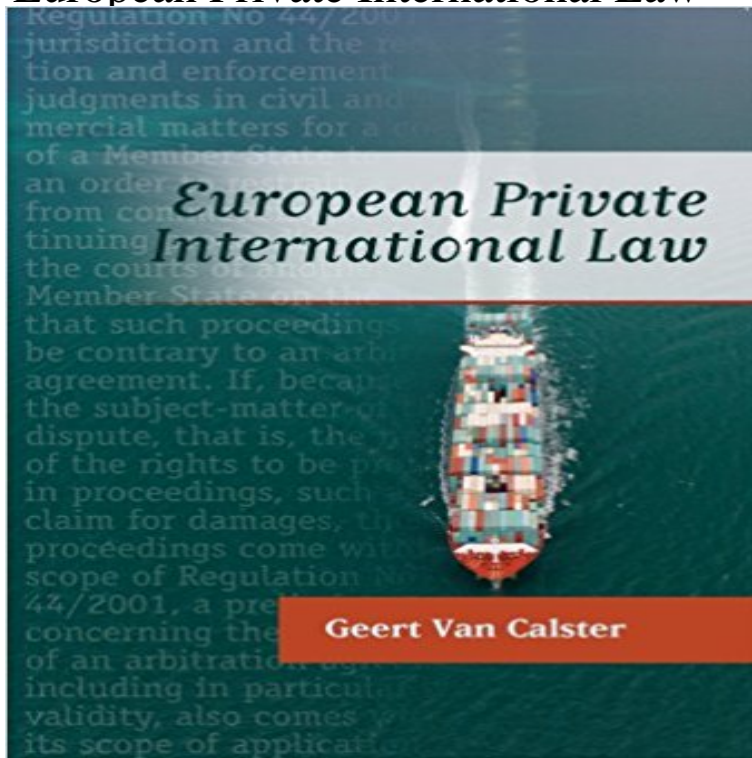


## European Private International Law
