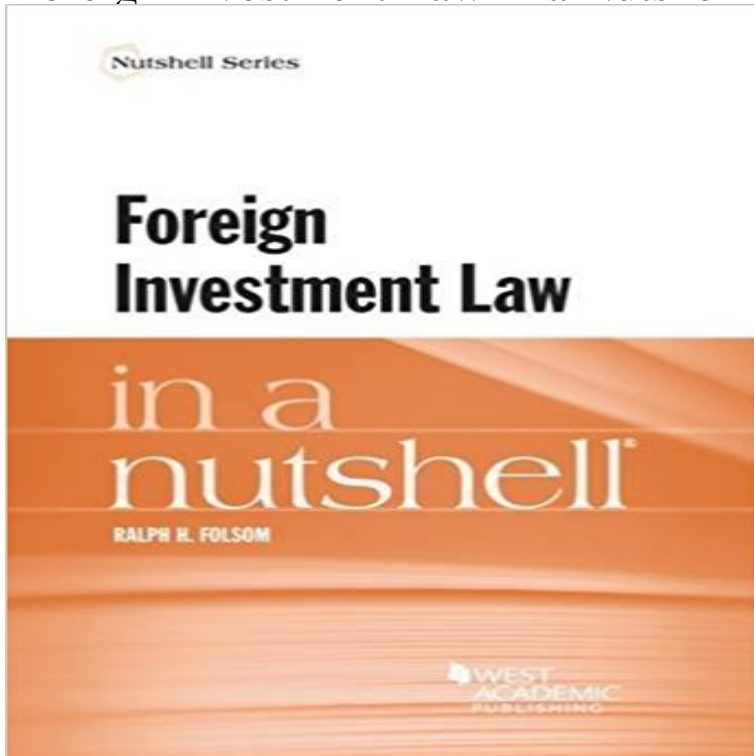


Foreign Investment Law in a Nutshell
