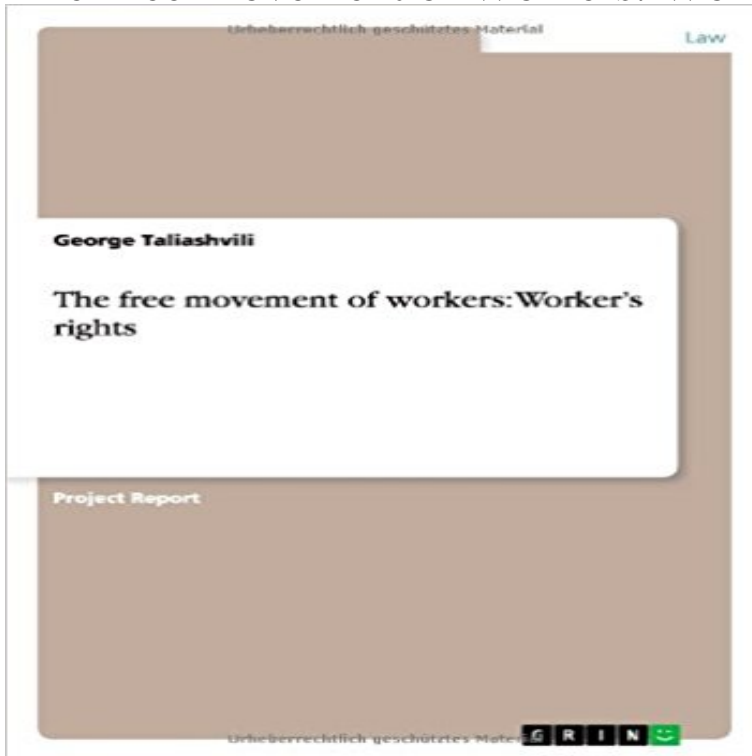


# The Free Movement of Workers: Workers Rights

In 1957 was signed the Treaty of Rome which laid the essential legal foundations for European Committee. After the establishing the European Committee its main tasks regarded to the achieving the high point of standard of living and economical expansion, for further development of mentioned tasks the Internal Market was subsisted by the EC treaty provisions which was the incarnation of Sir Winston Churchills idea and significant tool of economic integration, no boarders, no custom duties and the abolition of barriers to the free movement of goods, services, workers and capital within the member states known as the four

freedoms, was the great step towards the European consolidation.
