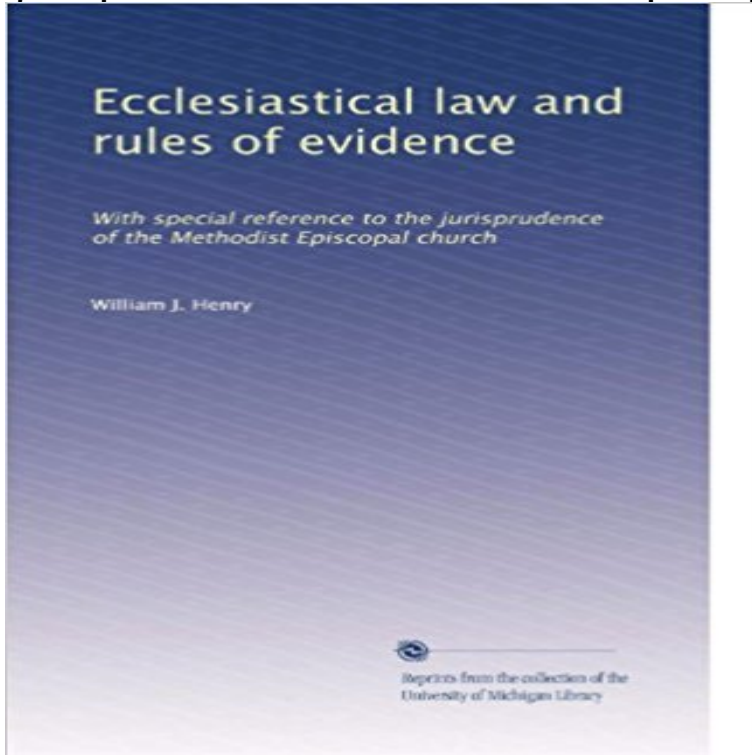


# Ecclesiastical law and rules of evidence: With special reference to the jurisprudence of the Methodist Episcopal church
