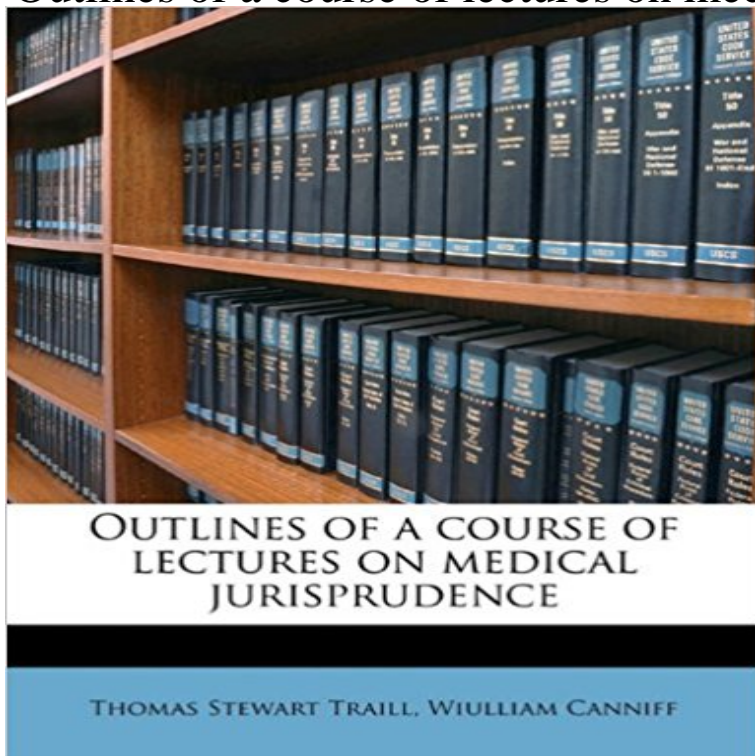


## Outlines of a course of lectures on medical jurisprudence
