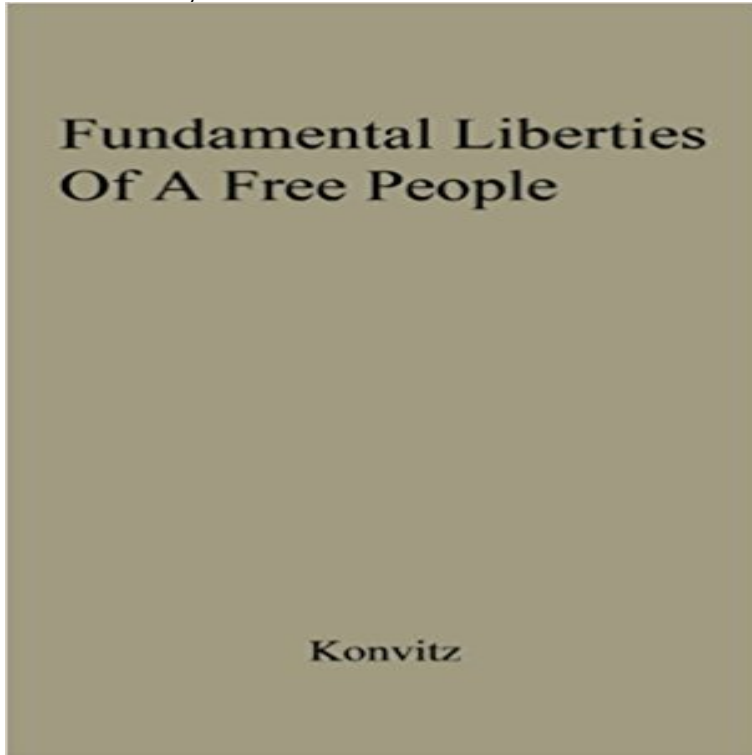


# Fundamental Liberties of a Free People: Religion, Speech, Press, Assembly
