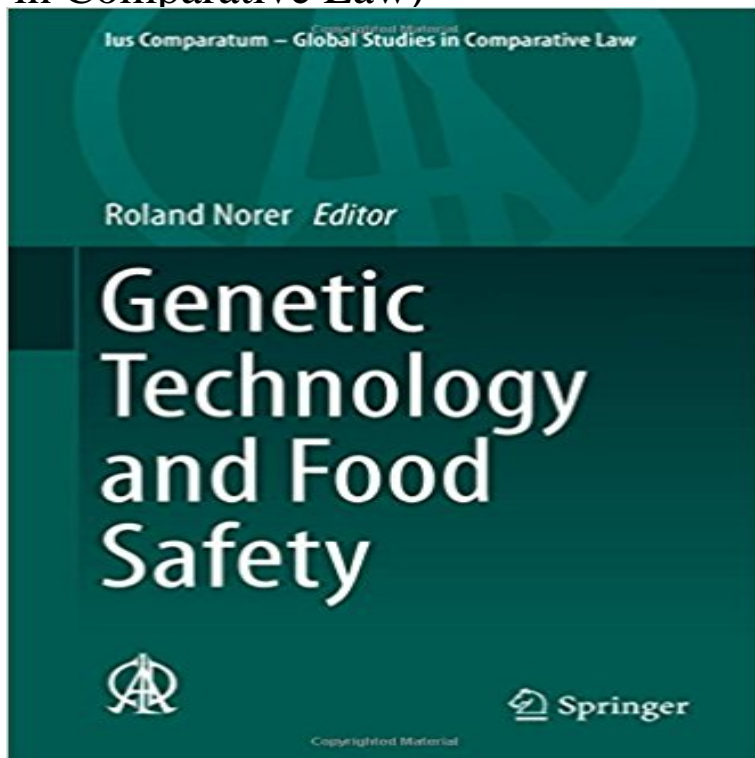


## Genetic Technology and Food Safety (Ius Comparatum - Global Studies in Comparative Law)
